What is Restorative Justice?

Restorative justice (RJ) is a voluntary process which



brings victims and offenders into communication. This can happen either directly, face to face, or indirectly.

For victims, it allows them to ask any questions that they may have been left with after the crime and the chance to **explain how** they are feeling to the person who caused the harm.

For offenders, RJ can help with **supporting them to** the understand consequences their of actions and in doing so, go on to make meaningful changes to prevent repeat offending. It also gives them the opportunity to do the right thing and try to make amends.

Case Study

Two neighbours, had been **experiencing escalating tensions** that led to frequent police involvement. These interactions often revolved around perceived **disturbances and boundary issues**. Both parties felt uncomfortable in their own homes and as if they were "**walking on eggshells**" due to the ongoing conflict. Restorative Justice was initiated and communication was facilitated through written letters. This allowed both parties the space to express their concerns and emotions without immediate confrontation.

Each neighbour worked with Victim First to discuss restorative justice and ensure they felt comfortable participating. Once both neighbours were ready, I facilitated the exchange of letters. Through the letters it became clear that both neighbours were experiencing a shared feeling of unease and frustration, each feeling their peace and privacy was being impacted. An agreement was collaboratively developed where they agreed to respect each other's privacy and property boundaries and committed to reducing behaviours that could cause further tension.

Following the restorative justice process, both neighbours reported a noticeable **improvement in their living environment.** By addressing the underlying issues through open written communication and mutual empathy, they successfully redefined their relationship from one of conflict to one of mutual respect, allowing them to feel comfortable and at peace in their own homes.

Being a Restorative Justice Lead means I that have the privilege of facilitating **meaningful conversations** that helps individuals to **address harm and foster understanding.** My work allows me to make a difference in people's lives by supporting and empowering them to find positive paths forward.

I've had a diverse journey in my career, each experience adding to my commitment to helping others. As a restorative justice practitioner in Birmingham, I enabled **impactful dialogues between parties**. I also coordinated a **gang prevention service**, working closely with at-risk individuals to support safer decision-making and reduce harm in our community.

One of the greatest highlights of my career is seeing young people I once supported now **thriving in education and work**. Knowing that I've played a part in helping them to become meaningful contributors to society is incredibly **fulfilling and drives my passion for this work**.
